1. CALL SESSION TO ORDER

Parks Advisory Board meeting called to order at 6:30PM.

2. ROLL CALL

Members of the Parks Advisory Board in attendance were: Perry Savard, Sharon Dyer, David Meyer and Alex Ramirez. Katie Weiss was absent.

Members of the City of Hutto Staff in attendance were: Jeff White, Parks Superintendent, and Angel Kavanaugh, Management Assistant.

3. PUBLIC COMMENT

DJ McPherson and Jonathan Motsinger (Texas A&M Forestry service) spoke about trees in our parks, Arbor day, a possible Adult park/ Relaxation park.

4. AGENDA ITEMS

- 4.1. Consideration and possible action on the meeting minutes from the regular scheduled Parks Advisory Board meeting held on July 20, 2022.

A motion was made by Board member Sharon Dyer to accept the meeting minutes from the regular scheduled Parks Advisory Board meeting held on July 20, 2022 as written, seconded by Board member David Meyer. Motion passed 4 Ayes to 0 Nays.

- 4.2. Update, discussion, and possible action on the Veterans Memorial.

Staff presented an update on the proposed Veterans Memorial. Kelly Kernandez of Russ Boles' office was in attendance with the Architect. At this point, all that is needed is for the Board to pick a location and design and they will present to the committee for the funds. Chair Perry Savard made a motion to nominate Board member Alex Ramirez to run point on this project, seconded by Board member Sharon Dyer. Motion passed 4 Ayes to 0 Nays.

- 4.3. Consideration and possible action on Parkland Ordinances.

The staff presented the Parkland Ordinances to the Board. A motion by Chair Perry Savard was made to approve staff recommendations and present it to council, seconded by Board member Sharon Dyer. Motion passed 4 Ayes to 0 Nays

A recommendation from Board member Sharon Dyer was made to hire a CNA for next year's summer camp for emergencies and medicine distribution. A motion to approve the 2022-2023 standards of care was made by Board Member David Meyer and seconded by Chair Perry Savard. Motion passed 4 Ayes to 0 Nays.

4.5. Consideration and possible action on the 2018 Parks Bond.

Chair Perry Savard made a request to move item 4.6 to 4.5 and was approved. A motion was made by Perry and seconded by Sharon to direct staff to proceed with Fritz Park as the first project. Ayes 4 Nays 0

Introduction of Parks Foundation Board members, Chair Perry Savard made a motion to approve new members to the Parks Foundation Board, seconded by Board member David Meyer. Motion Passed 4 Ayes to 0 Nays. Board Member David Meyer resigned as treasurer of the Parks Foundation.

Jeff updated the board on the budget hearing at city council on Aug 18, Sept 1 and Sept 15th.

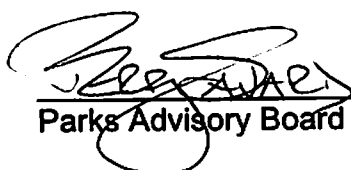
